1. Is there a statute of limitations for executing my judgment?
Yes. There is a time limitation for enforcing judgments – which varies from state to state. In New York State, judgments are valid for 20 years and may be extended beyond this period if the proper application is filed in court.
2. Can I use an attorney to enforce my judgment?
You can. However, few attorneys specialize in post-judgment enforcement or have access to the asset investigation databases which would allow them to locate debtors' assets. Additionally, you should be aware that attorneys will typically require you to put down a retainer and to pay hourly fees, even if they are not successful at recovering your judgment.
3. How long will it take you to enforce my judgment?
No two cases are the same, but typically it takes about 1 -2 months to enforce a judgment.
4. How can I get started working with you?
